Vice Mayor Pinquoch spoke briefly about sport fishing and suggested that Larry Gilman request a copy of the agreement between the State of Alaska and PWSAC that allows them to operate the hatchery.

There was some brief discussion regarding the harbor user fees.

Dave Pinquoch asked if it was possible for the Harbormaster and the Tax Administrator to get together and draft an ordinance changing the filing of user fee reports to quarterly so that it is the same as the filing for PTBT.

Mayor Daniel Blair recommended that the salmon project be put on the next council agenda under unfinished business and he asked Vice Mayor Pinquoch what he would like to name this project.

Vice Mayor Pinquoch replied "Sport Fish Enhancement Review"

#### 16. CITIZEN'S DISCUSSION

The General Manager, Thomas Guro from Begich Towers Condo Association stated that he just returned from attending an energy conference in Fairbanks and he spoke briefly about energy efficiency in large commercial buildings.

Thomas Guro spoke briefly about renewable energy resources and stated that he found a system in Seward that is a sea water heat pump/heat recovery system.

Thomas stated that he is looking into the same type of renewable heat source for the Begich Towers building and asked if the City would be interested in helping Begich Towers develop this source for City buildings here in the future.

Mayor Blair stated that there may also be grants available for this type of a project.
