A. Resolution #18-2020- A Resolution of The City Council Of The City Of Whittier, Alaska Recognizing The City of Whittier has been advised by the USACE District Office that the

total costs of the General Navigation Feature (GNF) may increase from what estimated in the Integrated Feasibility Report (IFR)

Jim Hunt: Okay, we are revisiting the resolution regarding the head of the bay and it's basically just acknowledging as—I'll back up a minute... former Councils, community worksessions we concluded in early feasibility studies and finally in—it was June of 2018, the Corps finished their investigation study for their feasibility at the head of that bay. And in that language, but without a number was that *there could be an increase of our match cost, due to the fact that higher levels of contamination could be found*. Originally, they hadn't put a number to it because it was early on in their studies and the draft. But they came back with a number we could possibly face-- \$4,000,000 additional cost and obviously we couldn't possibly absorb that for our community no matter what happened at the head of the bay in terms of what type of construct and what kind of infrastructure or business. So, it was stated that at any point in recognizing that this wasn't the language from far back and that the city's agreed to it by resolutions and public meetings. But despite this number, the Army Corps asked that, that is a possibility and that's what we're going to be doing tonight with the resolution but also adding in as stated at the first reading of the resolution when it failed was that we have the opportunity to determine as a community whether we want to go forward with his project or not. It could be no additional money, or it could be \$500,000 or \$100,000. There is a loan interest program available, but at this time, where we are, these early stages, they have acquired money for the planning, engineering, and design. And it's during this period, we'll be doing additional drilling into the dredging, soils and runoff coming off the shore. At that point, we'll determine what the cost will be to mitigate that issue. It is also at that point that the public and the Council can make a decision. That is where they are. And as I said before, the Corps is really hyped up on this. Back in Washington, there's not a lot going on here in Alaska. I went back and found a study that was done, I believe it was in 2011/2012 and it was a PowerPoint which we're going to present and it was given to us by the Mayor and it addresses everything we're talking about now; the pros, the cons, the economic feasibility, and what's available for us. I will say from a personal and professional standpoint, I've been watching Whittier for almost 10 years. I considered Whittier competition in my former position. I looked at Valdez, Homer, Cordova and our Finance Director and I, with our great Council, were able to acquit \$85,000,000 and almost no match funds for infrastructure in the community. Every project like this, for any future construction development avoiding sacred cows—whether it was the electric generation plant, new pavings, sewers, new breakwaters, uplands development—had many, many meetings attached to it. Administration followed the community and the Council lead. And that's what I really want to emphasize here. So, as we look at where we are, where we're going the opportunities that are presented to us right here is that nothing happens without the public, without the council giving administration directive. I understand this is new. This is likely one of the largest projects outside of demolishing the Buckner Building that we're going to face for a few years. I'd like Kris to come up—I've got 20 years of experience, about a 3rd of it here in Alaska, she's got 30 years of experience in working with communities, maritime infrastructure development planning. Before you speak, Kris, I just want to say, I was talking with the Mayor and thought it was a good idea if we had a Worksession where I brought in somebody from Northern Economics and maybe someone from either PND or RM Engineering, familiar with marine infrastructure and development and the economic impacts and have a big city-wide Worksession and talk about what the City wants. This has been on 3 comprehensive plans, lots of public input.

A. Whittier Seafood COVID-19 Update from the State – Dr. Anne Zink and team

Dr. Zink and her team reported on the findings after further examination was done at the Whittier Seafood plant and around the City. Dr. Joe McLaughlin and Donna Bean shared statistics and updated the Council on the status of the cases. Ken Newman with Whittier Seafood spoke at the podium about what was currently being done and reassured that Whittier Seafood, The City, and the State are all working together to create stringent protocols via Mutual Aid Agreement. Dr. McLaughlin and Dr. Bean expanded on the situation at length. Council discussed options with Holly regarding the City's Recovery Plan. Holly summarized the *Code Orange* option for the Council and Council discussed. Suggestions such as a two-week closure, recreational areas for plant workers, and strict social distancing protocols were explored. Holly addressed these concerns. Dr. Zink's team reassured that the Coronavirus has not made it to residential areas of the City and that Paul Mueller is working closely with Administration to provide testing.

MOTION: Debra Hicks made a motion to direct Administration to work with Whittier Seafood to create more stringent requirements and amendments to the Mutual Aid Agreement and an oversight structure

FINANCE MONTHLY REPORT

June Finance Monthly Report – with May PRELIMINARY financials

This report reflects an abbreviated look at finance-related *activities* through the end of June. Financial Report information is provided in the packet through the end of May. All interfund transfers budgeted for 2020 have been entered and posted; an adjustment was made to allocate the inter-department support over twelve months. A review will be conducted to ensure that all 2020 Budget Journal entries have been recorded in the financial statements prior to preparation of June Preliminary Financial Statements.

AUDIT COMPLETION

The final audited financial statements for 2019 are being presented to the City Council at the July Council meeting. Representatives from the audit firm Altman Rogers will be presenting the results of the City's annual audit at a work session preceding the Council meeting, followed by a brief public presentation. The City's audit was done remotely this year due to the COVID19 pandemic. The City underwent a State Single Audit but was not required to have a Federal Single Audit due to being below the federal expenditure threshold. The audit resulted in no audit findings. The City agreed with the auditors' recommendation to move \$958,385 of CPV grant revenues received on March 2, 2020, into the 2020 calendar year. While the funds were related to the 2019 season they would typically have been accrued into 2019 if received within 60 days of year end; however, since they were received outside of that timeframe, standard practice requires the revenues be recorded in 2020. This treatment is consistent with prior year.

INSURANCE

After completing and submitting the insurance exposure questionnaire and updating all insurance coverage schedules, the City received a quote from APEI (the City's current insurance provider) that resulted in a 41% increase in annual insurance premiums. This represents an increase of \$77,108, with premiums rising from the current \$187,864 to \$264,972 in 2021 based on essentially the same coverage and deductible levels. The increase for each line of insurance is as follows: Property (37%), Mobile Equipment (11%), Auto Coverage (41%), General Liability (41%) and Workers' Comp (53%).

We are told that rates are increasing due to the following: 1) the overall property insurance market is struggling as a result of worldwide catastrophes which has resulted in reinsurers exiting the market, leaving fewer options for coverage and increasing property insurance costs. Add to this, the City's three year claims experience related to events outside of the City's control (the 2018 earthquake and the Delong Dock fire), and we can expect higher premiums for multiple years; 2) general liability rates are increasing unrelated to Whittier's experience, primarily due to rising large claims from employment practices and child sexual abuse in schools. The abuse claims have resulted in large verdicts that the market previously expected to be barred due to statutes of limitation. Insurance companies did not build in adequate reserves for these claims due to existing statutes that appeared to otherwise bar the claims. This change of events requires insurers to build reserves to address potential claims; and 3) COVID19 has adversely impacted pool investments

causing APEI to reduce the sharing of excess capital which previously had the effect of reducing overall premiums, and the risk of exposure to illness or death resulting from the pandemic is impacting workers' comp rates applied to first responders, impacting most municipalities.

The City sought quotes for alternative coverage but was unable to secure quotes due to the three-year loss history. While we did increase deductibles from \$1,000 to \$2,500 for automobiles, an increase in deductibles for property was considered but rejected due to the added risk versus slight (\$4,000) reduction in annual premium. The administration will be strengthening its safety and training program to take advantage of opportunities to potentially reduce future annual premiums by up to \$35,000 annually but meaningful reductions in insurance costs will be possible only after the City experiences 2-3 years of reduced claims.

INTERNAL REVENUE SERVICE

At the end of June, the City for the first time, received notice from the IRS of its failure to timely file Form 940 (federal unemployment tax) for the years 2015, 2016, 2017, and 2018. The finance director is working to bring the City's filings current. This is the first notice the City has received related to this multiple-years' old issue. In following up on our request for abatement of more than \$130,000 in fines assessed based on the City's failure to file 2015 Forms W2 and W3, we are told the IRS has not yet recorded receipt of our request for abatement. The agent explained that since we filed our request for abatement in February, many IRS offices have been closed due to the COVID19 pandemic leaving mail unopened and unprocessed. As a result, we can expect further delays in the IRS' response to our request. We will continue to keep Council apprised of any progress.

GRANTS

Staff continue to research state and federal funding opportunities related to COVID19, to determine authorized uses of CARES Act and other funds. We are currently reviewing State CARES Act, federal FEMA grant and CPV COVID Mitigation funding related to the pandemic. Guidance is updated (and changes) on a regular basis making our planning difficult. It is crucial that we spend these funds on purposes explicitly authorized in the guidance, less we risk having to repay funding from the City's General Fund. We are taking our time to develop a plan that will meet all grant requirements. Given Whittier's recent outbreak of cases, we hope to better understand the community's areas of greatest impact and need, to ensure that however funds are ultimately spent, they target the areas greatest affected by the COVID19 pandemic. We continue to consider various scenarios and are working to develop recommendations for Council's consideration. Local businesses are encouraged to apply for State grant funds available through the AK Cares grant. These funds are not required to be repaid and grants are available for up to \$100,000 per business. The application can be found online at the Credit Union 1 website; the credit union serves as the State's partner in administering this grant program: <https://offers.cu1.org/small-business-aid-application>. It also appears as though Congress may extend assistance to small businesses for payroll protection, so local businesses are encouraged to review funding available to small business and non-profit organizations. [has submitted its signed grant applications to the State for the CARES Act and CPV-COVID funding.](#)

The City is working to finalize the Assistance to Firefighters Grant which provided a total of \$48,000 in funding to purchase 8 self-contained breathing apparatus for our fire department. After submitting the grant application, the cost of the apparatus increased such that the City was only able to purchase 7 units, with remaining funds purchasing extra SCBA bottles. We have submitted a modification request to the granting agency to be allowed to purchase only 7 units due to the cost increase. If that request is denied, the City may have to pay for one additional unit out of our existing budget.

The City continues to work with CRW and the State of Alaska to address necessary repairs resulting from the November 2018 earthquake. The insurance company sent representatives at the end of June week to assess damages and we await the result of their assessment. The current focus is on earthquake repair design services related to City Dock embankment and settlement repairs, Ocean Dock approach and pile and revetment settlement repairs, pavilion damage repairs, breakwater settlement repairs and Lift Station 4/5 settlement repairs.

Staff continue to work with engineers designing the next phase of the Shotgun Cove Road project. The next phase of the project may involve the need for an Environmental Impact Statement process which will extend the time necessary to move forward on construction, by an additional season.

House Labor and Commerce Committee hears testimony on the need to fix COVID-19 grant program

ANCHORAGE – Small business owners and economic development experts detailed a host of problems with the [AK CARES Grant Program](#) today during [a hearing of the House Labor and Commerce Committee](#).

The program was established with funding provided to the State of Alaska for pandemic relief through the federal Coronavirus Aid, Relief, and Economic Security (CARES) Act. Eligible businesses can receive between \$5,000 and \$100,000 in grants through the program.

As of June 29, however, only 167 of 1,947 applications, 8.5 percent, have been approved. \$6.3 million – just 2 percent of the available funding – is in the hands of Alaska businesses. Four major problems were highlighted by testifiers:

1. Commercial fishermen are not eligible for relief because their permits do not qualify as business licenses.
2. Trade organizations and chambers of commerce are ineligible for relief as they are registered as 501(c)6 entities.
3. Due to the way grant guidelines were written by the administration, the Department of Community, Commerce, and Economic Development is unable to make even minor regulatory changes to get funding out in a timely fashion.
4. Businesses that previously received other pandemic relief funding from the federal government are still struggling to access AK CARES Act grants.

Historic Permanent Fund Transfer Protects Alaska's Future

JUNEAU – On Tuesday, the State of Alaska made one of the most important investments in its 61-year history: a roughly \$5 billion transfer from the Alaska Permanent Fund's Earnings Reserve Account (ERA) to its principal account. This transfer is the largest of its kind, even larger than the deposit that established the Permanent Fund in 1977 of \$734 million.

The June 30 transaction closed out the 2020 fiscal year, contributing to the constitutionally protected account – meaning the Legislature cannot touch that money with a simple majority vote.

“In the future when they look back at history and what moved the corpus of the Permanent Fund, this will stand out,” said Senator Bert Stedman, R-Sitka, co-chairman of the Senate Finance Committee. “Some of us, including myself, want to move even more into the corpus. There is roughly \$12 billion that are now in the ERA, which can be spent with a simple majority vote of the House and the Senate. I think that’s too rich of a target for the folks in the Legislature that want an easy way out of the budgetary crisis, to just spend down the Permanent Fund and erode future dividends to all Alaskans, and I’m talking Alaskans that aren’t even born yet.”

This move does not change the Permanent Fund Corp’s investment strategy; nor does it hinder our ability to pay Permanent Fund dividends to Alaskans. Rather, it takes a significant amount of the fund’s liquidity and slides it over to the constitutionally protected side – making it accessible only by a statewide vote of Alaskans.
