- **Best Tasting Water in Alaska-**
 - The Whittier Water Department has won the “**Best Tasting Water in Alaska**” at the 2018 Alaska Rural Water Association Conference. This has been the 6th time in the last 11 years that we have won this honor. We will be sending our water back to the National Convention in Washington DC to compete for the title “**Best Tasting Water in the Nation**”. In 2015 we placed 3rd in the Nation. The City of Whittier has achieved this through the knowledge and dedication of Cam Bender –Sr. Water Operator, Junior Turituri – Water Operator and Gene Gillman –Water Operator in Training. When you see them please congratulate them on their achievement. This team makes sure that every day the water that comes from your tap is safe to drink and is the “Best in the State”
