1. CALL TO ORDER

Ed Hedges called the meeting to order at 6:00

9. NEW BUSINESS:

A. Harbor Update

Harbormaster stated that there isn't much going on as of right now. He mentioned that he is still working on the grant for the pump-out boat.

Dave Goldstein asked about City leases and asked the Harbonnaster if he was responsible for the leases along the waterfront, Harbonnaster replied that it is up in the air.

Mark Mitchell asked about the fire extinguishers in the Harbor and if they have been updated. The Harbormaster answered that he is going to submit a quote to replace all fire extinguishers and safety ladders to the Acting City Manager.

Dave Goldstein inquired about an incapacitated vehicle in the harbor. Kyle Sinclair clarified that he got approval to replace the engine on that vehicle.

B. Harbor Policy and Recommended Changes

The Harbornaster mentioned that changes that needed to be made and that the he needs to go back and review the items in the handbook and make sure they are proper.

Dave Goldstein asked for a copy of the revised Harbor Policy and Procedures. Kyle said that a copy will be sent out to all Commission members. He clarified that submission to the City Manager was to be done after Commission reviews the changes and agrees to them. A worksession to discuss the changes was planned for 6 o'clock before the next scheduled meeting; date to be determined via Doodle Poll.

The Harbormaster inquired about the Commission's quarterly meetings. Greg Clifford specified that the change was made before his involvement in the Commission, but it was to his understanding that it had to do boat captain's schedules in the summer. Greg suggested a slight adjustment to the scheduling so that the Commission could hold meetings to review and approve the Harbor budget. Dave Goldstein disclosed the reason for the meetings going from monthly to quarterly.

Commission briefly discussed the DeLong Dock and the status of where it is in terms of possession.

The Harbormaster replied that they (Fish and Game) provide the food and the pens, the city maintains everything. Ron Graham voiced his concerns about the number of fry decreasing over the last few years. Dave Goldstein clarified that that State provides the Chinook and PWSAC provides the Cohos. Kyle Sinclair explained that shutting off the water in the winter prevents pipes from bursting. He stated that the only water right now is coming from the Harbor building, everything else has to be drained. Kyle stated that he will have a talk with Brad VonWichman to find a way to supply water to him and other boaters when they need it. The issue will have to involve Public Works Director Scott Korbe.
