BOAT LIFT USE AGREEMENT

WMC 12.04.080 G

Description and weight/size limits: MARINE TRAVEL LIFT, MODEL 30 AMO; lifts maximum 30 Ton. CWH limits weight to approximately 25 Ton for margin of safety. The maximum width is approximately 15' 6".

The undersigned, for themselves and the owner and operator of the vessel identified below (collectively "Renter") agree to be available or have my designated agent on site during any moving of the boat. Renter also understands that this is an equipment rental agreement only. The City is not acting as a subcontractor and assumes no liability for injuries or damages including, but not limited to, all physical injuries and death arising out of the boatlift use. Renter shall defend and indemnify the City for any such claims made against it. Renter hereby releases and holds harmless City from any claims arising directly or indirectly from damages to, or caused by, any boat being lifted or transported including, but not limited to, all physical injuries and death regardless of whether the damage was caused by the City's negligence or otherwise.

The boat owner/agent must supply the jack stands, required plywood for under the stands, and **ground covering (tarp) for under it; all debris must be placed in bags, appropriately labeled and properly disposed. Ground covering and proper bagging and disposal of debris applies to "SHORT LIFTS" as well.**

BEST MANAGEMENT PRACTICES

City of Whittier Harbor

Haul-out Facility

1. Vessels hauling out requiring pressure washing must place a trap under the vessel and collect all debris coming from the washing operation. No material from the vessel may escape to the harbor. If material is found to be escaping the area all work will be stopped by the harbormaster.
2. Vessels in the Dry Storage Area must have tarps placed below the vessel under jacks or cribs and the tarp must extend to perimeter of the vessel to catch any material that comes from work being performed. If material is found to be escaping the work area all work will be stopped by the Harbormaster.
3. No work exceeding zinc replacement, prop work, or simple bottom painting activities will be allowed in the Dry Storage Area. No sandblasting, total bottom paint removal or significant work is allowed. Those types of activities must be done in a total containment shipyard environment.

I have read, understood and agree to these rules. I will not allow any material related to my activities in the haul-out and Dry Storage Area to escape into the environment.
