## GRID USE AGREEMENT • WMC 12.04.150

Any vessel using the grid must schedule with the Harbormaster's Office prior to use. No material from the vessel may escape to the harbor, therefore, pressure washing is **not allowed**. If materials are found to be escaping the area the Harbormaster will stop all work.

No work exceeding zinc replacement, prop work, or simple bottom inspection and painting activities will be allowed on the Grid. No sandblasting, total bottom paint removal or significant structural work is allowed. Those types of activities must be done in a total containment ship environment.

I have read, understood, and agree to these rules. I will not allow any material related to my activities on the Grid to escape into the environment.

The vessel owner/operator agrees to indemnify, defend and hold harmless the City of Whittier and the State of Alaska and their representatives and agents from any and all losses or claims, costs, damages, judgments, awards, expenses, or liability to any person arising from any injuries including but not limited to bodily injury or death or damages sustained by any person or property in consequence of any act or omission by the vessel or the vessel's owner or operator, or by the vessel's or owner's agent, employee, customer, guest, invitee, licensee, or vessel owner/operator in any way related, directly or indirectly, to the use of the City of Whittier Harbor Grid.

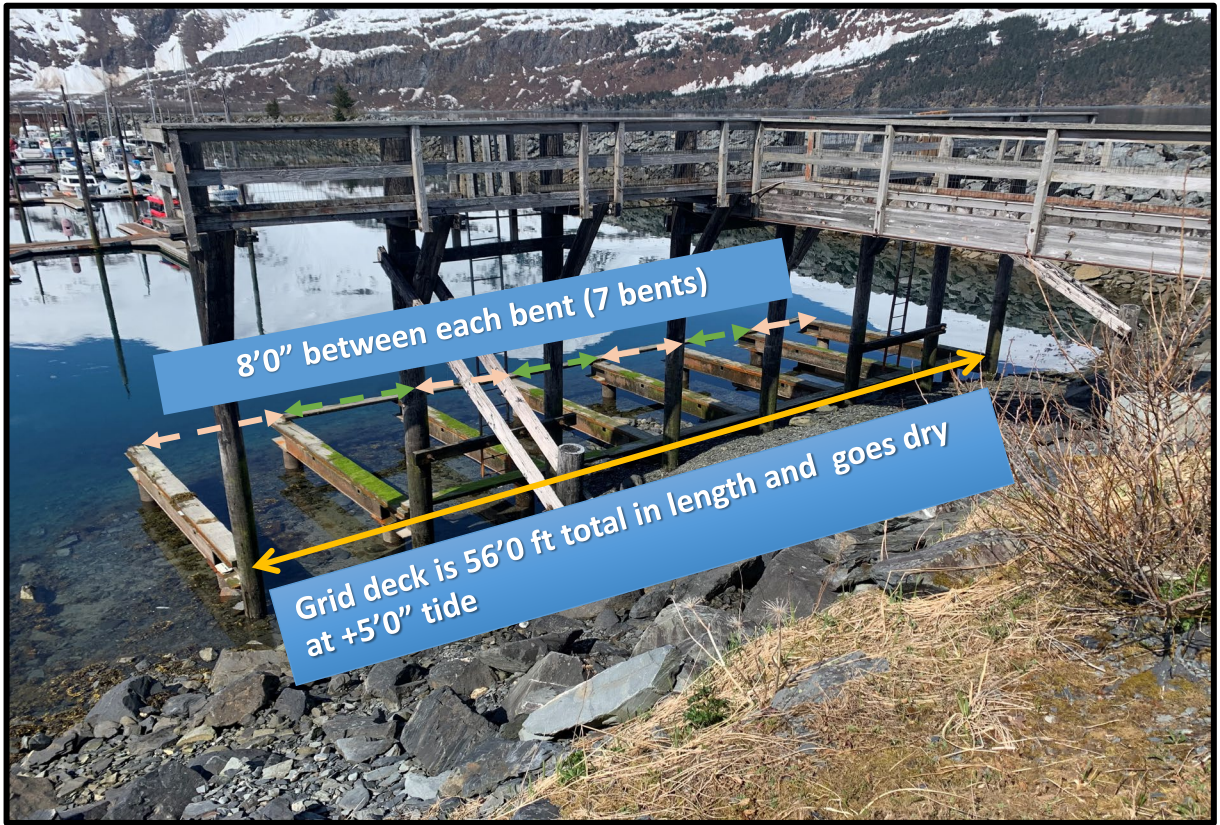
