**6. HARBORMASTER AND CHAIRPERSON REPORT**

Dave gave a report on the following:

**A. Delong Dock**

Dave also commented that the Harbor Municipal Grant program was not funded this year so progress at the head of the bay is moving slowly.

**A. Discussion topic: Harbor Title Ordinance**

Steven gave a brief update as to why the ordinance was brought forward to the Commission. The Commission discussed the Commission as it was historically and its purpose provide information and recommendations to the Council. Dave Goldstein described the Commission's duties. Jim Hunt clarified the confusion in the city's code as the Commission is listed as a quasi-judicial board by ordinance and not an advisory board like how it is practiced. He stated it is mostly in direct conflict in the code and stated that it is just to clarify that the Commission is in fact an advisory board. Dave Goldstein went on the record to express his support as well as the rest of the Commission.

**B. Upcoming Summer Season**

Steven Bender shared praise for the Harbor staff during the opening of the season and other Commissioners joined to thank the staff as well.

Dave Borg stated that he is hoping to update striping in the harbor.

Staffing in the harbor was mentioned. Dave gave an update on staff and how his schedule will look for the summer season i.e. working on weekends

The topic of trash was brought up and the Commission discussed dumpsters in the harbor as well as fees with the Harbormaster and the City Manager. Administration was directed to send invoices from June-September for trash. Discussion on the topic ensued.
